The future of the systems librarian

On 31 October SCONUL held a webinar to mark the launch of the SCONUL project on "The Future of the Systems Librarian. Georgina Dimmock, University of Northampton and Chair of the project working group led the discussion and we also heard from Adnan Adil from London South Bank University; Paul Smith from Coventry University and Margaret Stone from University College London. The discussion covered succession planning and whether routes into the systems librarian role may be changing; the importance of career advancement and personal development and the need for support and development for the community of systems librarians across the sector. Speakers identified challenges for the next five years including the need for continual upskilling and improved digital dexterity; Al skills; the on-going importance of soft skills; and the speed of change. The British Library is experiencing a major technology outage, as a result of a cyber incident. This is affecting online systems and services, their website, and onsite services including their Reading Rooms. The British Library are investigating the incident with the support of the National Cyber Security Centre (NCSC) and cybersecurity specialists. They are very grateful for the support and understanding they have had from users, staff and partners. The Library's sites remain fully open to the public and details on the services that remain available can be found via @britishlibrary on X (formerly Twitter). The British Library are working to understand and resolve the situation as quickly as possible and will share updates as soon as they can and are sorry for the inconvenience that this is causing.

The Scottish Confederation of University and Research Libraries (SCURL) EDI Network has launched a toolkit to support member libraries in embedding good practice consistently across services covering collections and discovery, demographics, glossary, resource lists, recruitment and student experience. The Toolkit has been designed as a whole staff resource, covering topics that are relevant across different roles within libraries. Read more

SCURL Rights Retention Statement Launched

SCURL has published its Rights Retention statement. In alignment with SCURL's aims to collaborate towards the creation of a co-operative library infrastructure in Scotland, and to provide mutual support for members, the statement supports the adoption of Rights Retention Strategies by SCURL HE Institutions. It is anticipated that SCURL HEIs will develop strategy, underpinned by the position set out in the statement, to facilitate the widest possible access to research. SCURL is also working to support open access publishing across Scottish institutions through the development of Scottish Universities
Press (SUP), a not-for-profit publishing platform managed in collaboration with participating institutions. Read more

OCLC Cataloguing and Metadata Subscription

RLUK have been in discussions with OCLC regrading metadata subscriptions and have reached a final agreement for a three year deal. This will start 1 August 2023 for a metadata subscription to OCLC, with a 3.75% annual uplift available to those RLUK institutions who wish to take it. For those who have already renewed at a higher percentage rate OCLC will credit the difference for year two, or re-issue 2023/2024 invoices to suit as required. In addition to this, an updated agreement would also include: reclamations associated with the alignment of holdings in Worldcat to promote accuracy of linking (for example, but not exclusively, to facilitate participation in the Google Project); access to NACO for those institutions wishing to undertake the training; Google search enhanced linking for those libraries wishing to participate. IFLA World Library and Information Congress 2024 not going ahead

The IFLA President and Secretary General have advised the IFLA membership and community that the Emirates Library and Information Association have <u>withdrawn their invitation</u> to hold the 2024 World Library and Information Congress in Dubai. As there were no viable options for WLIC 2024 and the limited time available, this decision means that there will now not be a World Library and Information Congress (WLIC) in 2024. <u>Read more</u>
