

### Pathfinder Projects

The OA Good Practice Pathfinder projects will support and complement universities' work on OA compliance and enable the creation of a range of resources that they can tap into as their own need dictates.

The projects will help us search out what's working well for institutions as they implement OA policies so that these examples can be shared widely across the sector. Through working to bring librarians, repository managers, research managers, researchers and others together to open up focused conversations, the projects will ensure that lessons learned once don't need to be learned afresh by someone else. There won't be a 'one size fits all' solution, but there will be a rich variety of experience and support to draw upon.

To ensure that, from the start, the current projects are oriented to sharing their experience, the lead HEI will be working in close collaboration with associate HEIs and, where appropriate, that publishers, intermediaries and systems vendors be included as unfunded partners in order to enhance the benefits to HEIs that these stakeholders can bring.

### **Jisc OAIC webinars: 'HEFCE OA requirements for REF'**

In response to HEFCE's new policy for open access relating to future research assessments, the first Jisc Open Access Implementation Community webinar provided an opportunity for delegates to receive an overview of the policy and to pose questions and comments to HEFCE and Jisc directly. Presentations considered the implications of the policy on research and the assessment of research as well as what services, tools and guidance were available or were forthcoming to support institutions in the implementation of this policy. Underpinning all these considerations were what key issues would need to be addressed if full implementation is to be fully realised.
