#### **SCONUL** conference: Future-ready libraries - presentations

Our *Future-ready libraries* conference took place on Wednesday 18 January and bought the community together face-to-face for the first time since the pandemic to discuss common experiences and to share learning, and to collaborate on planning for the future. There were excellent keynote presentations from Professor Susan Orr on developments in blended learning and teaching, and from Margaret Ayers of UHR on the sector-wide challenges on recruitment and retention. The community also discussed our direction on AI, on sustainable libraries, on integrating physical and virtual library spaces, on the scope for collaboration on collections and on the future post transitional arrangements. #### **Rights Retention Strategies**

The development of rights retentions policies is a growing area of interest for SCONUL members. On 26<sup>th</sup> January, SCONUL held a community webinar to share information on recent developments which heard from institutions which have successfully introduced such policies and provided an opportunity to share questions, experiences, and practice. The webinar included a presentation from Chris Banks of Imperial College London on recent developments and from leaders at three institutions which have agreed new rights retention policies: Tom Shaw of Lancaster University; Anna Clements of University of Sheffield and Eddy Verbaan of Sheffield Hallam University. ### SCONUL survey on library technology and markets – volunteers for a pilot

The survey will help SCONUL and its members identify areas of library activity in which there is a lack of competition or poor performance; evaluate potential suppliers; and identify emerging areas of library activity and the existing or emerging technologies being employed to meet these. # Scoping study to support an Emerging Leaders programme for members of ethnically diverse communities within libraries

Alongside RLUK and Libraries Connected, CILIP, SCURL and WHELF, SCONUL is supporting a project to scope the creation of a cross-sector Emerging Leaders' programme for colleagues from ethnically diverse communities from across the library sector. The project is being funded by the Arts Councils and the participating partners. The study will look at whether the <a href="Leading Libraries programme">Leading Libraries programme</a>, recently delivered by Libraries Connected, the University of Birmingham Leadership Institute, and CILIP, and supported by Arts Council England, provides an appropriate blueprint for a cross-sector programme, and whether any adaptations would be required. #### **Library Requirements for Future OA Academic Book Agreements Survey**

The UKRI Open Access Policy includes a new requirement for monographs, book chapters and edited collections published from 1 January 2024 to be made open access within 12 months of publication. Jisc is negotiating and promoting a range of Diamond OA monograph agreements where there is no fee to read or to publish, but institutions can support the publication of immediate OA content either by leasing or purchasing paywalled backfile content or contributing to the publication fund by way of an annual membership fee. They are seeking member views via a survey is to understand sector working practices and funding, and support for these initiatives. This will allow Jisc to finalise their negotiation approach and devise a variety of UKRI policy compliant licensing methods.
