Controlled digital lending in UK higher education: a landscape review

Controlled digital lending in UK higher education: a landscape review written by Jane Secker and Chris Morrison offers a follow-up to the briefing paper published by Jisc, SCONUL and RLUK in 2024 Controlled digital lending (CDL) in UK higher education: a Jisc briefing for libraries. Controlled digital lending can support access to content not otherwise available in digital format, enabling libraries to provide accessible and inclusive readings to students, provide remote access to special collections or to supply out of commerce works. Published in September 2025, the latest report builds on earlier work to assess the current state of controlled digital lending (CDL) in UK academic libraries. Data gathered in spring 2025 through a national survey of 58 institutions, interviews with seven institutions, one vendor and a consortium solution provider underpin the report. It considers the status of CDL implementation in academic libraries, the use cases driving adoption, technical requirements for implementation and currently available solutions. The report also considers the benefits, costs, barriers and legal implications of CDL, whilst concluding with some practical recommendations for institutions and library leaders as well as for Jisc, SCONUL, RLUK and other sector-level bodies. Launch of the UK Print Book Collection (UK PBC)

RLUK, SCONUL, Jisc, and the British Library have launched the UK Print Book Collection (UK PBC), a national initiative designed to preserve and provide access to scarce print monographs across the UK. The launch event, held on Wednesday 22 October, attracted around 130 attendees from a wide range of libraries. A recording of the event can be watched here. A second session (with the same content) will take place on Monday 10 November, you can sign up for this event here. The UK PBC is a shared service administered by the British Library and underpinned by the National Bibliographic Knowledgebase (NBK), operated by Jisc. The success of the UK PBC depends on as many libraries as possible signing up to supporting a national distributed collection of monographs based on a minimum number of seven retained copies across the participating libraries (seven libraries with a copy). Any Higher Education and specialist library in the UK is welcome to join. There is no fee. The only prerequisite is to contribute your bibliographic data to the NBK and refresh it regularly (support is available for any libraries needing assistance). IFLA selects London to host the 2027 World Library and Information Congress

IFLA <u>has announced</u> that the World Library and Information Congress will take place in London and across the UK in August 2027 after a successful bid by a partnership led by CILIP. 2027 is IFLA's Centenary year, marking 100 years since the original 15 library associations came together to create the International Federation of Library Associations and Institutions. This will also be the year that marks the

150th anniversary of the UK hosts, CILIP, own founding as the Library Association. While the multi-day Congress will take place at the Excel Centre in East London, there will be events held across the capital and all four UK Nations. Read more

Behind the scenes at SCONUL

SCONUL has completed the first stage of its work on the <u>HE Reference Models</u> which are widely used across HE. The working and review groups have agreed a set of proposed changes to the core Capability Model so that this more accurately reflects libraries' contributions to institutional capabilities across the Board. These proposed changes have had a positive initial reception from the UCISA-led review group and we look forward to seeing them reflected in changes to the next iteration of the model. We have also agreed to lead a consultation with library colleagues internationally, seeking their input into the proposed changes; and are considering possible changes to other elements of the HERMS library of materials; how members might be supported to deploy the model; and will be inputting into the new Service catalogue that is due to be developed in 2026.
