- Mary Millard, Executive Director of Faculty Operations at University of Bristol and sponsor of Bristol's Professional Services Transformation Programme which has led the development of the institution's service catalogue based on the HERMs.
- Iain McCracken, Director of Service Delivery at the London School of Economics. Iain is leading the development of the new HE Service Reference Model and he will set out the background to its development; share the alpha version of the Service Model and discuss how the SCONUL community can engage with this work.

SCONUL Spring Conference 2026

Over 100 SCONUL members gathered in London to focus on *Openness Under Pressure: Strategic leadership for libraries in an era of disruption*, on 1 May. Professor Karen Stanton, Vice-Chancellor of University of the Arts London, gave a presentation on the challenges and opportunities facing UK HE – effectively a masterclass on leadership for libraries. The conference explored the library community's commitment to openness and how it can be maintained in the face of countervailing pressures including growing economic and political nationalism and cybersecurity concerns. Delegates also had the opportunity to consider how to prepare for a future shaped by Gen Z and Alpha learners. Conference presentations will be available on the SCONUL website shortly.

UK Open Bibliographic Metadata Group – Call for Members

If you are interested in the possibilities afforded by open bibliographic metadata to boost the discoverability and visibility of library collections this may be the group for you! A SCONUL task and finish group reporting into the SCONUL Markets and Technologies Group, the UK Open Bibliographic Metadata Group has three strands of activity:

- Technological solutions and infrastructures: examining approaches, opportunities and providers that could help us realise an open metadata environment in the UK.
- Policy and licensing: reviewing the legal situation in the UK and EU with regard to copyright, the contractual position with our suppliers and options for developing an open metadata policy framework and template.
- BIBFRAME and linked open data: testing BIBFRAME as a vehicle for creating a linked open metadata environment, raising awareness of BIBFRAME and developing an understanding of options beyond BIBFRAME for a linked open bibliographic data environment.

UKRI open access policy update

UKRI have announced an update to the way their OA policy is implemented for 2026–30 which can be found in this LinkedIn post: [\(24\) Post | LinkedIn](#). Key points are that OA levels for UKRI articles are now around 88%, with steady growth in immediate OA but that the transition to full OA is slow. It will retain a flexible, multi-route approach to immediate OA and maintain its investment in OA. Funding will continue to support transitional agreements, but from 2028/29 UKRI funding will focus on fully OA publishing and will no longer be available for hybrid OA. It will also work in partnership to make targeted investments that strengthen Green OA and repository infrastructure including identifying opportunities for greater coordination and shared approaches. Their aim is to support more resilient and sustainable UK-wide infrastructure. More details will be announced in the coming months.

NHS Wales E-Library / WHELF project around the future of Open Access in Wales

Working with [Home - Research Consulting](#), NHS Wales e-Library and WHELF are collaborating in exploring options around Open Access in Health and Social Care publications in Wales. The final report considers the role of infrastructure, the value of grey literature, the importance of collaboration and the relationship between bilingual publication and Open Access. The clear commitment of both sectors to improve OA in Wales for our nation was a clear driver in the shaping of this project. Electronic legal deposit material available from the British Library

For the first time since a cyber-attack on the Library in 2023, electronic legal deposit material is now available to view at the Library. Material catalogued before October 2023, including journal issues, journal articles and ebooks can be viewed using the PCs in their Reading Rooms, while the [interim online catalogue](#) is available to find material.

Research Professional Futures (RPF) is a four-year initiative funded by Research England, delivered in partnership by Teesside University, Durham University, King's College London, and the University of Warwick. The programme aims to strengthen research culture and reshape how research is delivered across the UK. RPF focuses on supporting the development, visibility, and working practices of Research Professionals at all career stages. Through this work, RPF aims to better understand the roles, experiences, and aspirations of colleagues and use these insights to drive meaningful, positive change. A series of individual and institutional surveys will be launched in the summer, giving Research Professionals the opportunity to share their experiences and perspectives. During the same period, colleagues will be invited to take part in interviews and/or focus groups as the next phase of the project develops.
