### Leading change on race equality, 13 March and 27 March

SCONUL is partnering with AdvanceHE to bring members subsidised development workshops on 'Leading Change on Race Equality' as part of our ongoing commitment to increasing Equality, Diversity and Inclusion in the sector. The two linked workshops are designed to strengthen knowledge, skills and confidence to lead progress on race equality in college, national and university libraries. In partnering with AdvanceHE, we are able to offer a significantly discounted rate to support participation and development across the membership. The workshops will be two interactive sessions and will be facilitated by AdvanceHE Senior Advisor [Dr Lindy-Ann Blaize](#), who is experienced in anti-racism training and working with and within universities. The course fee is £95pp. The first workshop will be held on 13 March (AM), with the second session on 27 March (AM). The workshops are limited to two people per institution and designed for those in Senior Leadership roles. Places are limited and offered on a first come, first served basis. ### Springer Nature

Following the decision of the sector to reject the recent proposal from Springer Nature, SCONUL is organising a further briefing for members on the latest developments, and to discuss possible next steps. We will be sending an invitation to take part to the SCONUL Directors' list shortly. This follows the joint statement of support from mission groups, signed by Guild HE, MillionPlus, N8 PVC-Rs, the Russell Group and the University Alliance which said the latest proposal—which was received in November and rejected by the team negotiating on behalf of UK universities—does “not meet the needs of the sector and our members”. ### SCONUL signs statement calling on suppliers to reduce prices in cost of living crisis

SCONUL has come together with partners across the sector to make clear to publishers and other vendors the importance of ensuring value for money at a time of financial challenge. Signatories to the statement, which cites a “perfect storm of declining resources and increased demands”, include: UUK/Jisc content negotiation strategy group; UUK/Jisc software negotiation strategy group; British Universities Finance Directors Group (BUFDG); Research Libraries UK (RLUK); UCISA; Southern Universities Purchasing Consortium (SUPC); Scottish Confederation of University and Research Libraries (SCURL); Scottish Higher Education Digital Library (SHEDL) and the UK Universities Purchasing Consortia (UKUPC). ### Survey on Covid-19 Collecting in UK Galleries, Libraries, Archives and Museums

Members are invited to participate in a survey on Covid-19 Collecting in UK Galleries, Libraries, Archives and Museums. The survey is relevant to organisations that have not undertaken any Covid-19 collecting, as well as those that have. It forms part of an AHRC-RLUK Fellowship project on Documenting the Role of UK Science in the Covid-19 Pandemic, being conducted by Amelie Roper (Cambridge University Library). It has full approval from the Humanities and Social Sciences Research Ethics Committee at the University of Cambridge. The survey consists of a series of short questions and should take no longer than 15 minutes to complete. A [copy of the survey questions](#) is available to view in advance. More than one response per institution is permitted. However, if you are not involved with collection development in

your organisation, it may be more appropriate for you to ask a colleague to complete the survey instead. ### **Vacancy: Cataloguing Librarian - Project Officer (Race Equality Initiative), Cardiff University**
